



Alumnus Offers Up to \$10,000 to Help Wipe Out Deficit

Would Match Dollar for Dollar of Other Gifts

Sewanee will finish the current fiscal year without an operating deficit if alumni and other friends of the University combine to match the generosity of one unnamed alumnus.

Announcement to this effect was made by Vice-Chancellor Benjamin F. Finney at the annual meeting of the Associated Alumni, when he said that an anonymous benefactor had then and there volunteered to match, dollar for dollar up to \$10,000.00, the combined gifts of other alumni toward balancing the budget.

The estimated budget deficit for the current year, which ends August 31, was \$58,635.00 when the budget was made up. By June this amount had been reduced by \$37,500.00, including gifts totaling \$24,000.00 and operating economies effected to the amount of about \$13,500.00.

Thus, Dr. Finney explained, the operating deficit at the close of business June 30 was about \$21,000.00. To this amount, he said, must be added the sum of \$5,300.00, representing extra-budget expenditures, but he expressed the conviction that if the budget deficit is cleaned up, the latter item will be taken care of as well.

The Vice-Chancellor was careful to explain that the offer of \$10,000.00 on the part of the alumnus was not an outright one but was contingent upon the willingness of other able alumni to give in proportion to their means.

Dr. Finney was jubilant over the prospect of finishing a fiscal year without an operating deficit for the first time since 1929.

"I am confident," he told the ALUMNI NEWS, "that Sewanee men will take full advantage of this rare opportunity to do a real service for their Alma Mater. The timely generosity of our fellow alumnus, who prefers to remain anonymous, is thrilling to us all. We cannot fail to respond to such a challenge as he has thrown down to us."

The announcement was received with enthusiasm by the alumni present at the annual meeting. For purposes of concerted effort in raising the amount required, a committee was appointed, consisting of J. Howell Shelton, '08,

Dr. Finney Postpones Date of Retirement

One of the most rousing demonstrations ever seen on the Mountain was staged by students, members of the Faculty, and Commencement visitors here on the afternoon of June 5, a few minutes after it had been announced that Dr. Benjamin F. Finney, for fifteen years Vice-Chancellor of the University, had consented to postpone for a year his retirement as Sewanee's executive head.

Dr. Finney had proposed his own retirement in a statement to the Board of Trustees the year before, making it effective July 1, 1937, and making it contingent upon a sweeping reorganization of the University's administrative affairs.

As noted elsewhere in the ALUMNI NEWS, the reorganization was effected

Board Reorganizes to Give the Regents Wide Powers

Sewanee again re-enforced her claim to leadership in the educational world when the Board of Trustees, at the annual meeting in June, completed a thorough reorganization of the University's administrative affairs.

Amending the Constitution wherever indicated by the demands of the new aim for Sewanee, the Board relinquished to a reconstituted Board of Regents all the powers except the right to amend the Constitution and the authority to elect members of the Board of Regents, a Chancellor, a Vice-Chancellor, a Chaplain, and its own Secretary.

Under the re-organization the fifteen members of the old Board of Regents were automatically retired and twelve new members—three Bishops, three clergymen, and six laymen of the Episcopal Church—were elected.

The new Board of Regents consists of the Chancellor, the Vice-Chancellor the Rt. Rev. Frank A. Juhan, D.D., the Rt. Rev. Henry J. Mikell, D.D., the Rt. Rev. Charles Clingman, D.D., the Rev. R. Bland Mitchell, D.D., the Rev. Thomas N. Carruthers, M.A., the Rev. Charles W. Sheerin, D.D., Warren Kearny, D.C.L. (Chairman), L. Kemper Williams,, D.C.L., Frank Hoyt Gailor, D.C.L., Joseph E. Hart, Sr., William E. Baldwin, D.C.L., and Charles E. Thomas, B.A.

Vice-Chancellor B. F. Finney, in commenting upon the reorganization, said that it was "the greatest forward step undertaken by Sewanee in fifty years."

A point to which attention was particularly drawn by Dr. Finney, and one which brings Sewanee into line again with the more aggressive educational leadership, was that the Board of Regents, immediately after receiving its new authority, took action granting members of the University Faculty a place on the Standing Committees having to do with educational policies.

Standing Committees were named as follows:

MARKED BY CHEER

Development of local alumni organizations was one of the most important points stressed at the annual meeting of the Associated Alumni held on June 7.

The point was emphasized in a strong appeal by Edmund C. Armes, '13, of Birmingham, and many others followed in supporting it as the one great objective if the alumni group is to become the force for Sewanee that it should be.

Col. Harry T. Bull, '01, probably sounded the keynote of the meeting when he called attention to some of the things that were actually being done by the University. He not only made a most encouraging report of University activities but was enthusiastic about Sewanee Military Academy and the University Farm.

Vice-Chancellor Benjamin F. Finney was given a rousing ovation when he stood to make his report, since two days before he had announced his decision to defer his retirement for a year. A few minutes later he stated that an alumnus, who preferred to remain anonymous, would match dollar for dollar up to \$10,000, the gifts of others toward wiping out the deficit. SEWANEE TO HAVE

NEW UNION THEATRE

Work on the new Sewanee Union Theatre, authorized by the Board of Regents at the June meeting, has begun and the building is expected to be ready for occupancy early in the Fall.

The theatre will be an extension of the present Union building, to the rear with an entrance through the present lobby.

It will have a seating capacity of 400—a main floor capacity of 314, augmented by two balconies, one seating 50 white people and one seating 40 Negroes.

There will be no stage, but there will be a platform large enough to accommodate an orchestra.

A new heating plant will heat it in winter, and an air-cooling system will condition it for the Summer.

The sandwich shop will also be remodeled, with a hardwood floor, a real counter, three booths, and new tables added.

H. A. Griswold, '28, in addition to his duties as instructor in Greek and Bible, manages the Union Theatre and Sandwich Shop.

Sewanee Confers Degrees on 47 at Commencement

New Spirit Prevails in Old Ceremony

Sewanee conferred degrees in course upon forty-two students, and honorary degrees upon five men distinguished in the world of affairs, at her Sixty-Ninth Commencement Exercises.

With the atmosphere cleared by the epochal happenings of the preceding few days, and with the colorful ceremony of the Episcopal Church as a background, the exercises were held in All Saints' Chapel on the morning of June 8.

The Hon. Horace Russell, General Counsel of the Federal Home Loan Bank Board and President of the Federal Bar Association, of Washington, D.C., delivered the University oration, urging Sewanee graduates to join with other young college men in leading the American people, by means of thrift and home ownership, into economic and social security.

Robert Emmet Gribbin, Jr., of Asheville, N. C., gave the Latin Salutatory, and Benjamin Phillips, Jr., of Galveston, Texas, the valedictory address, for the graduating class.

Dr. George M. Baker, Dean of the College of Arts and Sciences, and the Rev. Dr. Charles L. Wells, Dean of the Theological School, presented to Vice-Chancellor Benjamin F. Finney the candidates for academic and theological degrees. Dr. Finney presented to Chancellor Theodore D. Bratton the candidates for honorary degrees.

Dr. Finney Advocates Adopting "Sewanee"

Vice-Chancellor Benjamin F. Finney, in his address at the annual Alumni Dinner, startled and challenged many of his listeners when he visualized "Sewanee University" as the one great national university owned and controlled by the Protestant Episcopal Church in the United States.

In speaking of the future of the University, Dr. Finney said that he could anticipate the time when the Board would change the official name from that of "The University of the South" to that of "Sewanee University", and the time when the twenty-two southern dioceses now owning the University would offer it, under the new official name, as a gift to the whole Church.

He pointed out the fact that it is as "Sewanee" that we are most generally known; that we call ourselves Sewanee men; that the direct and intangible cost of advertising the same institution under two names is excessive; that the name "Sewanee University" was one of the names suggested in the beginning, and that if it became a national university the present title would be a misnomer.

The Vice-Chancellor told of how Princeton University had been forced to change its name after struggling with its official title of "College of the State of New Jersey" for over 150 years.

The Church, he pointed out, has allowed its institutions of higher learning one by one to pass out of its control, so that today Sewanee is the only one left that proclaims its allegiance to and ownership by the Church. He called attention to the present trends of higher education toward secularization, through elimination of religious instruction, and toward socialization by the State.

The Church, Dr. Finney concluded, needs a great university of its own through which to impress itself on the educational world, and the nation needs such a great Christian university as Sewanee would unquestionably become as a National Church enterprise.

THE UNIVERSITY OF THE SOUTH, Sewanee, Tennessee, is owned by twenty-two dioceses; fifteen in Province of Sewanee, and seven in Province of the Southwest.

Ownership carries with it responsibility for its proper maintenance and support.

The University operates three main educational enterprises: College and Theological School, known locally as the University, and a Secondary School, the Sewanee Military Academy.

Founded in 1857. Opened in 1868.

Situated on top of Cumberland Plateau in South-eastern Tennessee at an altitude of 2,000 feet, owning its own domain of 10,000 acres. Reached by Nashville Chattanooga and St. Louis Railroad, and National Highway No. 64.

Approved by Association of American Universities.

Member of Association American Colleges, Southern Association of Colleges and Secondary Schools, Southern University Conference, Tennessee College Association, and the National College Athletic Association, Southeastern Conference, and Tennessee Intercollegiate Athletic Association.

Value of Plant \$1,348,134. Total Endowment \$2,117,950, of which \$1,250,000 is productive. that is the income of which is available for general operation.

The territory embraced in the owning dioceses is 890,000 square miles, with a population of 31,187,943, and containing 175,000 communicants, in 800 parishes.

The only University in the United States planned to consist of separate independent undergraduate colleges.

The only University or College in the United States announcing itself, according to the report of the American Council on Education, as being owned and controlled by the Protestant Episcopal Church.

One of only 84 colleges in the United States exclusively for men.

One of only 25 colleges in the United States exclusively for men which are on the approved list of American Universities and which also have chapters of Phi Beta Kappa.

The school charges are as low as or lower than in 20 of the above 25 colleges.

Enrollment 1936-37, University 260; Sewanee Military Academy 117.

Enrollment in the University this year is drawn from thirty states.

Seventy-one per cent of the student body communicants of the Episcopal Church.

Total of twenty-three departments in the University with a faculty of twenty-eight.

The members of the faculty hold earned degrees from 30 colleges and universities and 50% of them are listed in *Who's Who*.

Ten per cent of student body in College are sons of clergy who pay no tuition charges.

Another ten per cent are Theological Students, who pay no tuition.

Still another ten per cent are local county boys who pay only one-fifth of the tuition charges.

Of the total charges to students this year, including fees, room, board, and laundry amounting to \$168,000, the University furnished from funds, work, etc., \$41,000.

There are eight National Greek letter social fraternities owning their own houses used only as club rooms, and five National Honorary societies: Phi Beta Kappa, Omicron Delta Kappa, Pi Gamma Mu, Sigma Upsilon, and Blue Key.

The Library contains over 50,000 volumes.

The students are housed in six modern stone dormitories or halls, accommodating thirty to fifty each, with a matron or house mother in each, and their meals are served in two dining halls.

There are for use of the students in the University and Academy, two well-equipped gymnasiums, and basketball courts, one containing a 75-foot modern swimming pool; a 9-hole golf course, three football fields; five tennis courts.

Daily Chapel in both University and Academy with a Chaplain in both having over-sight of the spiritual life of the students.

The *Sewanee Review*, published by the University, is the oldest as well as one of the best Reviews published by any university.

In addition to the three main educational enterprises, College, Theological School, and Academy, the University corporation operates a Press, Laundry, Water Works, Farm, Supply Store, Theatre, and a well-equipped modern Hospital with four doctors on its staff.

Deficit Practically Erased as Year Ends

Total of \$11,965.61 Is Raised to Match \$10,000 Offer Made by Alumnus

Matching dollar for dollar the ten-thousand-dollar gift of an anonymous and generous alumnus, who made the offer through Vice-Chancellor Benjamin F. Finney last Commencement, alumni and friends of Sewanee contributed liberally to the 1937 budget deficit account.

At the close of the fiscal year, August 31, Dr. Finney reported that the special gift had been matched and that a total of \$21,965.61 had been given, thus bringing the University nearer to a balanced budget than at any time since 1929. Of the amount raised, \$16,-849.12, including the \$10,000 anonymous gift, was given by alumni.

This is regarded as a remarkable achievement, in view of the fact that when the budget was prepared for 1936-1937 the estimated deficit for the year was \$58,635. When by June this amount had been reduced by \$37,500, through gifts and operating economies, the possibility of wiping out the deficit became apparent. The proffered gift of the unnamed alumnus made the possibility a probability.

When the matter was presented at the annual meeting of the Associated Alumni, it was received with enthusiasm. President Niles Trammell, '18, appointed a committee consisting of J. Howell Shelton, '08, of Dallas, Texas, chairman; Roland Jones, '25, Beaumont, Texas, and the Rt. Rev. Frank A. Jahan, D.D., '11, Jacksonville, Fla. This committee did effective work and many alumni responded to the special opportunity provided by the ten-thousand-dollar offer.

University officials, greatly pleased with the response to this special appeal, are pressing the ten-year program adopted by the governing boards a year ago. The first step in the plan, which contemplates raising \$1,500,000 additional endowment within the ten-year period, is to seek assurance of annual gifts amounting to the income of a million dollars—that is, gifts totaling \$45,000 to \$50,000 each year until such time as the University is sufficiently endowed.

Last spring the Department of Public Relations, headed by Chancellor

Resigns Chaplaincy

Rev. Mr. Guerry Leaving Nine Years Chaplain, Accepts Call to Norfolk

The Rev. Moultrie Guerry, for the last nine years Chaplain of the University, resigned November 17 to accept a call to be Rector of St. Paul's Church, Norfolk, Va.

The Rev. Mr. Guerry will hold his last service as Sewanee's Chaplain on December 15 and will take up his new duties January 1.

Son of the late Bishop William A. Guerry, of South Carolina, a former Chaplain of the University, and bound to Sewanee by lifelong ties, the Rev. Mr. Guerry is a member of the class of 1921. Following his graduation here he taught English in the College of Charleston for a year, then went to the Virginia Theological Seminary, from which he was graduated in 1925 with the degree of Bachelor of Divinity. He became Chaplain of his Alma Mater in January, 1929.

When asked for a statement concerning Mr. Guerry's resignation, Dr. B. F. Finney, Vice-Chancellor of the University, said: "No words of mine are adequate to convey my sense of personal loss. Mr. Guerry's going will leave vacant a place in the life of the University and in our community family which will be hard indeed to fill. For nine years he has been building daily his place in our hearts and lives and building for himself through devoted service a position of leadership throughout the Church, which entitles him to rank as one of the greatest of our Chaplains."

Seventieth Session Is Marked by Good Spirit

Students Come from Twenty-Six States; Forty-one Men Made Gownsmen

Sewanee's seventieth academic session is well on its way, with 219 in the College of Arts and Sciences, and 18 in the theological school.

Twenty-six States and the District of Columbia are represented in the enrollment. Tennessee leads with a contribution of 55 students; Alabama is second, with 33, and Texas comes third, with 18. Although the great majority of the students are from Southern homes, the Northern States are well represented, some students coming from as far away as Connecticut and Massachusetts.

The total enrollment is slightly less than that of last year, the decrease showing principally in the number of new men in residence. Upper classes, Registrar's statistics indicate, have held their own to an unusual degree.

Forty-one new members of the Order of Gownsmen were formally invested with their academic gowns by Dr. George M. Baker, Dean of the College of Arts and Sciences, at the traditional Founders' Day ceremony held in All Saints' Chapel on October 11. The Order of Gownsmen, upper-classmen's organization which sets the tone and guides the undergraduate activities of the campus, is unusually active this year under the leadership of Richard Bolling, its president.

And while student affairs progress in the traditional Sewanee spirit, those who control the fiscal destinies of the University are finding a great deal about which to be optimistic. The Board of Regents, wearing with good grace the new mantle of authority conferred upon it last June, met early in November, received the report of the auditors, and reported favorably on the financial condition of the University.

One point brought out in the report of the auditors, as presented to the Board, was subsequently published by Vice-Chancellor Benjamin F. Finney as an encouraging indication: an increase, over last year, of \$525,000 in capital funds listed on the University books. Of this amount \$325,000 represents the auditors' replacement of assets marked off during the early years of the business depression. The remaining \$200,000 is the amount of the Stetson legacy announced last year. Capital funds of the University now total \$4,592,000, according to the report.

Theodore D. Bratton, carried the matter directly to the twenty-two owning dioceses of the Episcopal Church. Members of the Church were told that the needs of the University would be met if their annual gifts equaled twenty-five cents per communicant. Two dioceses—Alabama and Tennessee—responded by placing Sewanee in their diocesan budgets. Many parishes and missions in other dioceses responded similarly, and many made a special offering on what was designated as "Sewanee Sunday."

Recently efforts have been made by the Department of Public Relations to conserve the gains thus made and to further the plan. It was pointed out that on "Sewanee Sunday" approximately twenty per cent of the amount needed was given, and that this twenty per cent was given by less than twenty per cent of the total number of parishes and missions in the twenty-two owning dioceses.

In the effort to reach the other eighty per cent, and so to provide the entire amount needed, the Department of Public Relations is being represented by a Presentation Committee, each member of which is visiting an area to which he is assigned.

This committee consists of Chancellor Bratton, Vice-Chancellor Finney, L. Kemper Williams, Warren Kearny, Gen. J. P. Jervey, the Rev. Moultrie Guerry, and Harrold R. Flintoff.

VARSITY FOOTBALL SEASON

It is difficult to write an account of the 1937 football season for the team played brilliantly at times, often against overwhelming odds, and then again made listless showings against other foes. Therefore, little more than the facts of the season will be included in this write-up.

Spirit ran high as the Purples opened their season with a splendid victory over Hiwassee College in the first opening game to be held on the Mountain for some years. However, this optimism was soon shattered as powerful Alabama ran rough-shod over the Tigers 65 to 0 in their next game. Then Sewanee bounced back into the win column by rouncing Tennessee Wesleyan, a team which had beaten them in the previous season. The team had an easy time and took the Wesleyanites into camp by a 25 to 0 score. An inability to score marked the Tigers' game with Florida in which they were defeated 21 to 0. Twice they had the ball almost on the goal

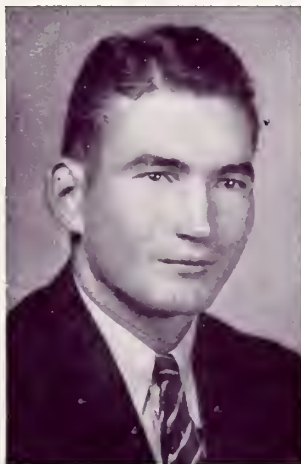


DR. EDWARD MCCRADY

line but lacked the punch to put it over. Tennessee was the Tigers' next opponent and succeeded in defeating them 32 to 0 in a driving snow which hampered the offense of both teams. An unexpected 9 to 6 defeat at the hands of T.P.I. was the result of the Purples' next game. The team played well in the first half and held a 6 to 0 lead as the whistle blew, but went to pieces in the last two quarters and allowed the Tech team to push over a touchdown and a field goal. Sewanee's traditional game with Vanderbilt found the Tigers completely outclassed and they went down 41 to 0. Sewanee had several chances to score but muffed them. She did succeed, however, in scoring thirteen first downs against the Commodores—more than any other one team was able to do. In their last two games, the Purples turned in very creditable performances. They held Mississippi State to a 12 to 0 victory, which was featured by a scoreless last half, and then lost to Tulane 33 to 7. Sewanee scored in the first half and held a 7 to 0 lead at the intermission. Unfortunately, too many Greenie reserves kept coming on the field and the tired Tigers were snowed under by five touchdowns in the last half.

New Faculty Members

Professor Dallinger, a graduate of Harvard and of the Episcopal Theological School at Cambridge, came to Sewanee from his native Massachusetts, where he has been engaged in parish work.

Freshman Football

At the beginning of the season twenty-six boys reported for Freshman football. From this number, Coach Gordon Clark developed about fifteen football players some of whom should prove valuable additions to the varsity next year. The Frosh played three games which resulted in two wins and one loss. Against the Murfreesboro Teachers freshmen, the Baby Tigers showed a fast offense and a fairly good defense in defeating their opponents 19 to 6. In their next game the Frosh ran roughshod over the T.P.I. first-year men and easily downed them 27 to 0. Report of the Secretary

The records for the past fiscal year ending August 31, 1937 again show a substantial increase in the active membership of the Associated Alumni. The number paying dues for the year reached a total of 497 which is an increase of 64 or 15 per cent over the preceding year of 1935-36. The honorary alumni group led all classes with a total of 29 active members and a large majority, 24, of the 1937 graduating class became active members.

ALUMNI FUND

The sum of \$1,162.07 was contributed by 241 members of the Associated Alumni to the Alumni Fund. This is a new record both in number of contributors and in amount contributed and is an increase over 1935-36 of 45 contributors and of \$160.56 in amount contributed. The entire amount was given to the University for operating expenses and represents the interest on an endowment fund of \$23,860, the rate of interest being the average earned on all University funds.

OTHER ALUMNI CONTRIBUTIONS

Contributions by alumni to other funds of the University also increased substantially. Two hundred and twenty-six alumni contributed the amount of \$34,683.00 to other funds as shown in the accompanying table. This in an increase over the previous year of 128 contributors and \$25,175.63 in amount contributed. The amount received from alumni dues, contributions to the Alumni Fund, and gifts to other funds of the University makes a total of \$37,336.07 which was given by alumni during 1936-37, an increase over 1935-36 of \$25,527.29.

SEWANEE ALUMNUS GIVEN RESPONSIBLE POST

A Sewanee man, Thomas Evans, '03, has been appointed by the Governor of Pennsylvania as Chairman of the Philadelphia Charter Commission which is charged with the responsibility of drafting a new law merging the city and county government.

A political independent, Mr. Evans is a keen student of governmental affairs and his appointment was welcomed by civic leaders of all parties. He is in no sense a politician and has never sought public office but he eagerly accepted Governor Earle's appointment as chairman of the Charter Commission because of the opportunity it offered for public service.

"Chairman Evans, known to his friends as Tom, was born in Florence, S. C. Though pressing 55, he looks to be in his 40's. Mild of manner, he combines the courtesy of a Southern gentleman with the exactitude of a successful business executive and the efficiency of a trained soldier.

"As a business man, Evans ranks with the best. He is president of Merchant & Evans Co., first vice-president of the Globe Automatic Sprinkling Company, and national chairman of the refrigeration industry, which last year did a business of \$500,000,000."

Dr. Alexander Guerry Accepts the Vice-Chancellorship

Unanimously Elected by Board of Trustees

On a June day in 1910, twenty-five capped and gowned young men joined the ranks of Sewanee's alumni, preparatory to making their bid for recognition in the world of affairs.

Among them was nineteen-year-old Alex Guerry, son of the Right Reverend William Alexander Guerry, Bishop of South Carolina.

That Sewanee-bred Alex Guerry loved and was loyal to the University which had just conferred upon him the degree of Bachelor of Arts, nobody doubted. That he would some day return to Sewanee as Vice-Chancellor of his Alma Mater was not foretold by the class prophet. Or if it was, the forecast is not a matter of record.

What is of record is that on December 17, 1937, Dr. Alex Guerry received and accepted the unanimous call of the Board of Trustees to the vice-chancellorship. It was the second invitation extended to him by Sewanee's governing board. Elected a year previously, he had chosen to remain at the University of Chattanooga, of which he had been president since 1929.

Dr. Guerry comes to Sewanee as chief executive on July 1. Dr. Benjamin F. Finney, whom he succeeds in office, retires on June 30, after sixteen productive years of service as Vice-Chancellor. However, the incoming executive head is already working with his predecessor on comprehensive plans for the future of the University.

The new Vice-Chancellor is a member of a family which has been identified with the life of Sewanee for nearly sixty years. His father was graduated from the University, with the degree of Master of Arts, in 1884; completed his theological studies here in 1888; served as Chaplain and Professor of Pastoral Theology and Homiletics from 1893 until his elevation to the episcopacy in 1907, and was active on the Board of Trustees from that year until his death in 1928. Dr. Guerry's three brothers—the Rev. Sumner, the Rev. Moultrie, and the Rev. Edward Guerry—are alumni of Sewanee. The Rev. Moultrie Guerry served as Chaplain of the University from January, 1929 through December, 1937, when he became Rector of St. Paul's Church, Norfolk, Virginia.

Alumni Asked to Help Balance 1938 Budget

Thirty-thousand dollars in special gifts will be needed to enable Dr. Alex Guerry, who on July 1 takes office as Vice-Chancellor of the University, to start off his work with a balanced budget.

Dr. Benjamin F. Finney, retiring Vice-Chancellor, reveals this information in an open letter to Sewanee alumni. The letter, headed "Making Your Contribution Double," is printed in a box on page 2 of this issue of the *Alumni News*.

Dr. Finney says that, by the time this statement reaches this paper's readers, he will have promises of \$15,000 of the needed amount, offered on the basis of its being matched dollar for dollar. Thus, he points out, those who contribute to the "matching fund" will make their gifts perform double duty.

The letter explains further that all gifts to the Alumni Fund and all money contributed for Regents' Scholarships,

Dr. Finney Has High Praise for Successor

Dr. Benjamin F. Finney, whose sixteen-year period of service as Vice-Chancellor of the University will be brought to a close with his retirement July 1, has high praise for his successor, Dr. Alex Guerry.

In a letter to alumni, given to the *Alumni News* for publication, he repeats what he has said of Dr. Guerry on other occasions: "Had I been asked to select the man out of all the educators in the country to become the Vice-Chancellor of our University, he is the one I would have unhesitatingly chosen."

Dr. Finney bespeaks for his successor the "loyal and unswerving devotion and support" of the alumni. His letter follows:

"My dear Fellow Alumni:

"It is now sixteen years since I was called to become the executive head of the University.

"These years have been filled for me with much hard work, but always with great joy. For the University they have been eventful ones in her life, and many and great have been the changes that have come to pass. In physical plant, in endowments, in curriculum, and in the form of administration the University is in better position to serve the Church and Nation and is, I am sure, nearer her ultimate destiny of greatness. Through all the change, however, the spirit of the place has not changed, and she is still the Sewanee of our boyhood days.

"To all of you who have during these years helped me in the great but joyous task laid upon me I wish to express my heartfelt thanks.

"As I come to the end of my term of service and on July 1st resign the trust committed to me in 1922 I wish you to know that no greater joy could come to me than the knowledge that the man chosen as my successor in office is my devoted friend Alexander Guerry. As I have stated in other places, had I been asked to select the man out of all the educators in the country to become the Vice-Chancellor of our University, he is the one I would have unhesitatingly chosen, and I bespeak for him all of your loyal and unswerving devotion and support—confident that with this

EVERY GIFT COUNTS

The campaign for annual dues, gifts to the 1937-38 Alumni Fund, and contributions for the University's current operating deficit is hereby begun. Last year's record—498 alumni paying dues, 241 alumni contributing \$1,162.07 to the Alumni Fund, and 226 alumni giving \$34,683 to some other fund of the University, making a total of 570 contributors and \$37,336.07 in amount contributed—set up quite a high mark, but we are hoping to make it higher this year, and believe that it can be done.

There is a rather general tendency, especially on the part of people who have moderate or small means, to discount the value of the small gift. They probably do not stop to think that many small amounts, added together, make a large total. We have said before, but it is worth repeating, that it is not the size of the gift but the number of givers that counts.

It is our hope that as many Sewanee men as possible will get into the habit of making a gift to the University each year. These combined gifts represent the income from a large endowment fund because they are sent in annually. The amount given should be determined by each alumnus according to his means. We again suggest that each man put Sewanee in his yearly budget along with his club, lodge, and church.

Printed elsewhere in this issue is an appeal from Dr. Finney for gifts for the Matching Fund to wipe out the operating deficit for the current year. As indicated in Dr. Finney's letter, gifts to the Alumni Fund will be put in the Matching Fund and will, therefore, be doubled.

We hope that a large number of the enclosed postage-guaranteed envelopes will be returned promptly with the proper enclosure.

The following paragraph and table showing statistics on gifts of alumni of other institutions are taken from the May, 1935, issue of *University Facts*, printed by the University of North Carolina:

"If University of North Carolina alumni sometimes feel that they never hear from their Alma Mater except when some request is made, they may take consolation in the fact that the same applies to alumni of other institutions. The alumni of virtually every

REUNION OF SAE'S

A reunion of all Sewanee S.A.E.'s is being planned for the coming Commencement. The following paragraphs are taken from a letter from H. C. Woodall, '17, chairman of the Executive Committee:

"In the summer of 1937 a small group of us discussed the potentialities for success of a reunion in Sewanee of the alumni of Tennessee Omega of all classes. From this beginning, plans have definitely taken shape and the first announcement has gone out to some four hundred for whom we have addresses.

"Aside from the fact that we should all have a good time getting together with brothers and friends with whom we haven't frolicked in many a day, it seems particularly fitting that we should assemble in June of this year, to pledge our cooperation and express our faith in the University's future under our new leader, the Vice-Chancellor-elect, Alex Guerry, a Sewanee man and an S.A.E.

"The Executive Committee is planning a vigorous program over the next three months to bring the reunion to the attention of all our brothers; the plan should be infectious, inducing an unusually large gathering of Sewanee alumni, whatever pin they may wear."

Chairman of other committees are: Col. H. T. Bull, Finance; H. A. Griswold, Accommodations; Gordon M. Clark, Reception; and Phil B. Whitaker, Program and Entertainment. Colonel Bull is undertaking to raise a fund to finance the reunion and contributions are being sent to J. Albert Woods, 120 Broadway, New York City, who is acting as Reunion Treasurer.

Sewanee Called Cameo of American Universities

The columns of *The Chicago Daily News* carried last fall the following tribute to Sewanee, written by Dempster MacMurphy, a member of the paper's staff who was with a political group on a tour of Tennessee:

"The high spot of the tour up to the moment, probably of the entire journey was a pause at Sewanee, the University of the South. In gathering dusk the party could trace only the outlines of natural and architectural charms of the place, but its members entered the chapel and found there an American Westminster, with memorials to great figures Sewanee has given to church and nation—among them Hudson Stuck, Gorgas, and Archie Butt.

"There, too, they sensed something of the spirit of this famous and at the same time little known institution atop the Cumberland plateau. Its small company of students, living beautifully in an atmosphere as old world as Oxford, enjoy an intimate personal relationship with a distinguished faculty—a faculty that stands, as Sewanee has ever stood, for taste, for culture, and for character.

"The cameo of American universities, Sewanee is a high adventure in education and a high ideal for citizenship. Alone, it is worth a pilgrimage to Tennessee."

FUTURE ATHLETIC POLICY

Sewanee's future policy regarding athletics was given a great deal of publicity as a result of an article printed in the *Nashville Tennessean* on January 23. The article was based on a letter which it was stated had been received by a Nashville alumnus from Dr. Alexander Guerry, Vice-Chancellor elect and said, among other things, that it was understood that Sewanee would withdraw from the Southeastern Conference. When questioned regarding matter, Dr. Guerry made the following statement:

"I regret very much the premature announcement from Nashville concerning the future football program at Sewanee. My letter from which the quotation appeared was a communication to the board of trustees, not an individual or group in Nashville. I would greatly prefer not to make any comment about athletics before I become Vice-Chancellor.

"Since the question has been raised, however, a frank statement seems necessary. It is true that Sewanee will abandon 'big-time' football and play teams in her own class as a general policy. The athletic scholarships will be abolished in 1939 except that students holding scholarships will remain in full possession until graduation. Withdrawal from the Southeastern Conference is not contemplated at this time."

on your part and under his able leadership, the University will go forward to a success dreamed of but never yet attained."

Dr. Finney, with characteristic reserve, dismisses his own long and fruitful term of service with a modest sentence predicated upon the word "change." However, alumni whose loyalty and devotion to Sewanee have gained their impetus during the last sixteen years, will be more than ready to expand that sentence into a volume.

Dr. Finney came to Sewanee as Vice-Chancellor in the Spring of 1922. Records show that since August 31 of that year the University has "changed" in these particulars:

The total capital assets have increased from \$1,650,562.05 to \$4,079,902.36.

All of the present dormitories except Hoffman Hall and St. Luke's Hall have been completed. Cannon Hall, Johnson Hall, and Tuckaway Inn—modern stone dormitories—have been erected. The Sewanee Inn and Quintard Hall (S.M.A.) have been completed. Other permanent construction includes the S.M.A. gymnasium and swimming pool, Ormond Simkins Field House, the Snowden Memorial wing at the hospital, the new Sewanee Union Theatre, and three professor's houses.

With the development of an adequate water supply and the consequent reduction of the fire hazard, the University now carries fifty per cent more insurance at ten per cent less cost.

The University farm has increased in size from 8 1-3 acres to 500 acres, many permanent improvements have been added, and the farm is stocked with a herd of 55 Jersey and Guernsey cows.

The curriculum of the College has been modernized and greatly strengthened. Quality credits have been established. Fields of concentration and comprehensive examinations have been introduced. Phi Beta Kappa is one of four national honor societies to grant Sewanee recognition since 1922.

Administrative functions have been

On the Mountain

THE NEW SEWANEE UNION THEATRE was opened during the Christmas holidays. The new building which is an annex to Thompson Hall, the Sewanee Union building, and which was constructed at a building and equipment cost of \$20,000, is to be used for the showing of motion pictures. It is built of Sewanee sandstone and the inside walls are finished in rough fieldstone. The seating capacity is over 400. The indirect lighting, air-cushioned seats, and new sound and projecting apparatus are some of the outstanding features of the new theatre. The main entrance to the theatre is through the center of the Union which was remodeled to provide a large lobby and staircase of stone leading to the box-office. The ironwork on the staircase, the entrance, the box-office, and the balconies in the interior was done by Mr. Martin Johnson, Assistant to the Vice-Chancellor. Rooms were built on one side of the new theatre for Dr. Kirby-Smith's office. The house formerly used for this purpose has been moved below the Torian house.

THE OLD MOVIE THEATRE is being remodeled and will be used as an auditorium for meetings, plays, and programs of various kinds. Room has been provided on the first floor of the Union for a music studio and the walls have been sound proofed. The Sandwich Shop has been redecorated and new equipment has been added.

THE POST OF CHAPLAIN of the University, vacated by the Rev. Moultrie Guerry, '21, who left Sewanee on January 1 to become rector of St. Paul's Episcopal Church in Norfolk, Va., is being filled by the Rev. John R. Dalling, professor of Old Testament in the Theological School. The temporary appointment was made by Dr. B. F. Finney, pending the election of a chaplain by the Board of Trustees in June.

A FAREWELL GIFT of one dozen sterling silver bread and butter plates and small butter knives was sent to the Rev. Moultrie Guerry shortly after he left Sewanee. The following message accompanied the gift: "To our Chaplain, with the gratitude, loyalty, and affection of his friends among the students, faculty, and residents of Sewanee, December, 1937."

AN ELECTRIC SCOREBOARD for basketball games was presented to the University by Blue Key, and was installed at the beginning of the basketball season. In addition to indicating the score, the board has a large clock, the official timing device for the game, which tells the number of minutes and seconds left to play in each half. At the end of each half a horn automatically blows. The board also indicates which quarter of the game is being played. The clock is electrically controlled from the time-keeper's desk.

THE MID-WINTER DANCES were held on February 7, the music being supplied by Will Osborne and his orchestra. Instead of the tea dance usually held on

PURPLE MASQUE PRESENTED the Jitney Players, a professional troupe, in two short plays on February 14. The dramatic group's own production, "The Bishop Misbehaves," was given on March 7.

PHI BETA KAPPA ELECTION added four members of the junior class to the group: Alex Guerry, Jr., Ernest Cotten, John Welsh, and Russell Turner. Dr. George Coffin Taylor, professor of

English at the University of North Carolina, will speak at an open meeting of the local chapter of Phi Beta Kappa on March 31. This meeting will take the place of the annual meeting during Commencement week.

FOUR FRENCH MOVING PICTURES will be shown during the spring in conjunction with the regular moving picture program. "Sans Famille," "Beethoven," "Itto," and "La Tendre Ennemie" are the titles of the pictures which will be shown.

THE INTERCOLLEGIATE DEBATE SCHEDULE has been completed. Debates will be held in Sewanee with Drake University, Springhill College, Davidson College, St. Edward's University, Allegheny College, Annandale-on-Hudson (Columbia University), University of Cincinnati, Waynesburg College and Tennessee Polytechnic Institute. Trips will be taken on which the teams of Tennessee Polytechnic Institute, Davidson College, Southwestern, University of Ten-

VARSIY BASKETBALL

The Purples lost games to Auburn, Tennessee, Southwestern, Georgia, Georgia Tech, T.P.I., Vanderbilt, and Chattanooga, the two latter defeating the Tigers in return games.

It is most interesting to note that, although three of the first five men on the team who began the season were lost on account of ineligibility and other reasons, the spirit displayed by the substitutes was such that Sewanee finished the season very creditably. At no time was Sewanee disgraced and the majority of the games were lost by a very small margin.

LaVerne Spake was high-point man of the season with 140 points. Following him were Sugg Keiser with 110; Dexter Stanphill with 61; and Arthur Whittington with 55.

FRESHMAN BASKETBALL

The Class of '41 had a fairly successful season winning eight out of seventeen games and climaxing the season by defeating the Vanderbilt Frosh 36 to 34.

A green group of freshmen reported to Coach Joel Eaves at the beginning of the season and it was in the early stages of the year that the majority of the games were lost. After he had whipped them into shape and found a suitable combination, the Frosh scored some impressive victories.

High scorers for the season were Currie with 216 points; Bodfish with 116; Julian with 97; and Macon with 28. These men should prove valuable material for the varsity squad next year.

About Sewanee Alumni

CARY T. GRAYSON

Rear Admiral Cary T. Grayson died at his home in Washington, D. C., on February 15 after a two-weeks' illness of a sinus-respiratory infection.

Born in Culpeper, Virginia, on October 11, 1878, Cary Travers Grayson received the degree of Doctor of Medicine from the Medical School of the University in 1903, having taken his pre-medical work at the College of William and Mary. He continued his medical work at Johns Hopkins University and the United States Naval Medical School. Upon graduation from the latter he entered the Navy as acting assistant surgeon. He became surgeon of the United States Naval Hospital in 1903, surgeon of the presidential yacht in 1905, and attending and consulting physician of the Naval Dispensary in Washington during the Roosevelt and Taft administrations. He was appointed to the medical staff of the White House by President Theodore Roosevelt and continued in this position by President Taft. Appointed as his personal physician by President Wilson, he accompanied him to Paris for the Peace Conference in 1919 and attended him until his death in 1924. He was given the rank of Rear Admiral by President Wilson in 1916.

Retiring from the Navy in 1928, Admiral Grayson began private practice. He also became head of the Gorgas Memorial Institute of Preventive Medicine and Tropical Research, a public health foundation commemorating General William C. Gorgas, '75. He was appointed by President Franklin D. Roosevelt as director of both his inaugural celebrations and as chairman of the American Red Cross in 1935. Shortly afterward he was elected chairman of the International Red Cross.

The honorary degree of Doctor of Civil Law was conferred upon Admiral Grayson by the University in 1936. He last visited Sewanee in 1933 when he represented President Roosevelt at the celebration in honor of Bishop Thomas F. Gailor's twenty-fifth anniversary as Chancellor of the University and fortieth anniversary as Bishop of Tennessee.

Tribute to the memory of Admiral Grayson, his friend of many years, was paid by President Franklin D. Roosevelt in the following statement:

"As physician, as humanitarian, and as Red Cross executive, Admiral Grayson touched life at many angles and did outstanding work in every field of endeavor. His earlier activities were a logical preparation for his work in these later years as chairman of the American Red Cross. Whether directing relief at home or cooperating in the alleviation of human misery in far lands, his tact, industry, and genius for getting things done made his work outstanding.

"But it is as a friend that so many of us will always think of Cary Grayson—a friend in the truest and finest sense of that fine word. A staunch friend, an old and close friend has been taken from us."

CECIL G. SELLERS

The following account of the death of Cecil Gray Sellers, '18, was written by J. Albert Woods, '18, and published in the March issue of *The Record of Sigma Alpha Epsilon*: "Captain Cecil Gray Sellers, Tennessee Omega, '18, first officer in command of the twenty-one-ton Samoan Clipper, lost his life when the Pan-American Airways flying boat plunged into the South Pacific on January 11. Capt. Edwin C. Musick, world flying ace, and six associates including Sellers, were carried to death when fire developed as the great plane was dumping its gasoline in an attempt to make an even keel landing near Pago Pago, Samoa.

"Captain Sellers, whose astounding flying career carried him through the World War and unusual aviation experiences in China without mishap, died in peaceful flight, as well as is known. The disaster was the first in the history of Pan-American's nearly three years of trans-Pacific flying. The crew had started on an 1800-mile non-stop flight to Auckland, New Zealand, a new route, but had turned back because the plane burst into flames in mid-air and plunged into the ocean. Fragments of the ill-fated ship were found after a twelve-hour search.

"First Officer Sellers was a World War Ace, a Distinguished Service Cross winner, and one-time personal pilot of Generalissimo Chiang Kai-Shek of China. News of the death of "Swede" Sellers was almost unbelievable to the members of Tennessee Omega who were at Sewanee with him, because they had grown accustomed to the career of the great flyer.

"While attending the University of the South, Sellers was a sensational half-back. During his junior year he went to Newport News where he began the study of aviation. When the United States entered the World War, he went overseas with the first fifty American aviators. He remained in the army after the war and reached the rank of captain. Later he went to China and joined the aviation service of the Chinese government. There, in 1932, he met Walter Campbell Kent, Tennessee Omega, '26, also a football man at Sewanee, the two not having known each other before. Kent was an instructor in the Chinese flying school. While in the Chinese service, Sellers became the personal pilot of Generalissimo Chiang Kai-Shek. It is said that he flew Madame Kai-Shek to her husband after the Generalissimo was kidnapped. Then he joined the Pan-American Airways, and was on his second flight in the Samoan Clipper when death suddenly ended the interesting career of the Tennessee man."

GEORGE S. WHEAT

George S. Wheat, vice-president in charge of advertising and publicity of the United Aircraft Corporation, died suddenly at his home in Darien, Conn., on December 26. Mr. Wheat entered newspaper work upon leaving college and was a reporter for the *Chattanooga Times*, the *New York Press*, the *New York Evening Sun*, and the *New York Herald*. In 1917 he accepted a commission as lieutenant in the United States Navy, and was a communications officer on a troop transport. He was a member of the Committee on Public Information, supplying President Wilson with news from America while he was attending the Peace Conference abroad. After the war Mr. Wheat opened a publicity office in New York, and later became connected with several aircraft companies. He edited the "Bee Hive," a monthly aeronautical publication, was the author of a book entitled "Municipal Landing Fields and Airports," and was a contributor to aeronautical magazines.

Mr. Wheat was one of the organizers of the American Legion and was the author of the first book explaining its purposes, "The Story of the American Legion."

Mr. Wheat was a native of Gallatin, Tenn. He is survived by his wife, Mrs. Ensley Hodgson Wheat, and three sons.

placed on what is expected to prove a much more efficient basis. Through the leadership of Dr. Finney the Board of Trustees, long regarded as too large and unwieldy to be effective, last June relinquished to the smaller Board of Regents all administrative powers except the authority to elect a Chancellor, a Vice-Chancellor, and a Chaplain.

It was to these and other developments of the last sixteen years that Dr. Finney referred when he expressed the conviction that the University is "nearer her ultimate destiny of greatness."

She and Dr. Guerry were married in 1914. They have two sons: Alex, Jr., high-ranking member of Sewanee's Junior class, and John Patten.

Their Sewanee home will be Fulford Hall, more familiarly known to many Sewanee alumni as "Benedict."

from now until August 31, will apply on the budget-balancing fund.

While August 31, the last day of the fiscal year, is the actual deadline for balancing the budget, Dr. Finney is anxious that the full amount of \$30,000 shall be in hand by June 30, when he turns over Sewanee's affairs to Dr. Guerry.

Alumni rallied generously last summer in a similar matching-fund effort. Of a total of \$21,965.61 raised for the purpose of balancing the 1936-37 budget, alumni gave \$16,849.12 including the initial ten-thousand-dollar anonymous gift.

DEAN OF THEOLOGICAL SCHOOL DIES ON APRIL 18

The Rev. Charles Luke Wells, Ph.D., Professor of Ecclesiastical History in Sewanee's Theological School since 1916, and Dean since 1922, died at his home here on April 18. He was buried in the University cemetery beside the body of his wife, who died in 1934.

Dr. Wells would have been eighty years old had he lived until June 23, the date of his birth in Boston, Mass., in 1858.

One of the most widely and affectionately known clergymen and educators in the Episcopal Church, Dr. Wells had spent fifty-five active years in the ministry, continuing to serve with remarkable vigor until a few weeks before his death.

He was educated at Harvard University, which conferred upon him the degrees of Bachelor of Arts and Doctor of Philosophy; and at the Episcopal Theological School, Cambridge, Mass., where he received the degree of Bachelor of Divinity.

After serving several parishes in his native state, Dr. Wells went to New Orleans as Dean of Christ Church Cathedral, later becoming Rector of Christ Church, Macon, Ga., from which parish he came to Sewanee.

His educational career, in addition to his long term of service here, included teaching at Harvard, at McGill University, Montreal, Canada, at Seabury Divinity School, and at Boone College, Wuchang, China.

His historical writings included "A Manual of Early Ecclesiastical History" and "The Age of Charlemagne."

INTRAMURAL ATHLETICS are the center of interest at the present time with soft ball, tennis, and golf in full swing. The swimming meet will be held later this month. The track meet was held on April 8 and 9, Sigma Nu winning first place with 55 points, Phi Delta Theta second with 39 points, and Phi Gamma Delta third with 36 points. The handball tournament was won by Sigma Alpha Epsilon with Delta Tau Delta the runner-up. The basketball tournament was won by Sigma Alpha Epsilon, Sigma Nu being second and Kappa Sigma third.

THE TRACK TEAM experienced a fair season, losing dual meets to Vanderbilt and Southwestern and defeating Chattanooga. In the Tennessee Intercollegiate Athletic Association meet held in Knoxville, Sewanee placed third among eight teams from all over the state with a total of 20 points. W. J. Cochrane took first place in the 120-yard high hurdles and second in the 220-yard low hurdles. Walter Higgins placed second in both the 100 and 220-yard dashes and Joe Frasier took second in the javelin throw.

SPRING FOOTBALL PRACTICE has been held since the middle of February and it has been the most successful practice ever conducted here. Games were played each Saturday until track practice began and signal drill and dummy scrimmage were carried on through the middle of May.

THE VARSITY TENNIS TEAM is completing another successful season, having won six of the eleven matches played. The Tigers defeated Mississippi State, Augustana, Birmingham - Southern, Chattanooga in two matches, and Mississippi College and lost to Wayne, Emory, Georgia Tech, Alabama, and Vanderbilt. A full team was entered in the annual Southeastern Conference tournament held at Tulane University, and our number one player, Alex Guerry, Jr., made an excellent showing, being defeated in the finals by Russell Bobbitt of Georgia Tech.
